(1) The Company entered into a purchase agreement with an independent third party on 8 January 2015 pursuant to which the Company has agreed to issue and sell the convertible notes with an aggregate principal amount of US\$120,000,000. Based on the initial conversion price (subject to adjustments) of HK\$1.956 per share, such convertible notes can be converted into 475,742,331 shares of the Company upon full conversion. On 23 January 2015, the convertible notes were issued. For more details, please refer to the announcements of the Company dated 9 January 2015 and 26 January 2015.

(2) Conversion price of the convertible notes was adjusted from HK\$1.956 per share to HK\$1.884 per share as a result of payment of Final Dividend for the year ended 31 December 2014. Based on the adjusted price of HK\$1.884, the outstanding convertible notes can be converted into 493,923,567 shares of the Company upon full conversion. For more details, please refer to the Announcement of the Company dated 7 July 2015.
